





EC.02.04.01 EP4, EC.02.04.03 EP2, EC.02.04.03 EP3 provide more guidance on expectations of completion rates, how grace periods affect completion rates, and how equipment that is in use or unable to be located affect an organizations completion rate.

FUNCTIONALITY

NEW FIELD	
Work Order PM Compliance Date	TJC refers to three PM dates: Start/Due Date, Done/Completed By, and Out of Compliance. The compliance date is added to ensure documentation and visibility of PM compliance—not just completion.
WORKFLOW CODES	
Active (open) Sub-status	The recent TJC clarification specified two conditions when PMs don't count for or against. These codes document meeting theseconditions.

REPORTS & DASHBOARDS	
TJC Work Order Detail Report	Adds the PM Compliance Date to PM Work Order report
TJC EIU/ENL Open Scheduled Work Order Listing Report	New dashboard report that allows customers to manage <i>open</i> PMs in the EIU (Equipment in Use) and ENL (Equipment Not Located) Sub-status
TJC EIU/ENL Work Orders Report (Scheduled Last 3 Months)	New dashboard report that allows customers to manage <i>closed</i> PMs in the EIU (Equipment in Use) and ENL (Equipment Not Located) Sub-status
TJC PM Compliance Report (Current Month)	New report where customers can breakout how many PMs are due, completed, could not locate, could not locate, could not be found in the <i>current month</i>
TJC PM Compliance Report (Previous Month)	New report where customers can breakout how many PMs are due, completed, could not locate, could not locate, could not be found in the <i>previous month</i>
PM % Completion w/ TJC Compliance Analytics Report (Date Range)	Provides graphs and details for a prompted date range of PM activity
TJC Open Scheduled WO Listing	New dashboard and report for real-time or printed access to open TJC EIU/ENL Open Scheduled Work Orders

Next PM Due Date Assignment	Automatically aligns PM next due dates with industry best practice scheduling by setting dates to the first of the month scheduled (Monthly or longer frequencies) or to Sunday of the week scheduled (Weekly/Bi-weekly frequencies)
Preventive Maintenance & Inspection Work Orders Assignments	Automatically aligns PM completion and compliance dates with industry best practice scheduling. PM Due becomes the last day of the calendar month scheduled (Monthly or longer frequencies) or Saturday of the week scheduled (Weekly/Bi-weekly frequencies)
REMOTE IMPLEMENTATION	
Imports	Custom report(s) and datasource(s)
Modifications	Relation to adding or subtracting fields or adding/subtracting filters BUT NOT including altering report structure (SQL), those reports included in this package
Adds	New dashboard (or add new data sources to an existing one)
	New Compliance Date field and apply it to the respective modules
	(or modifies) Work Order and Schedule forms to contain new Compliance Date field
	New Work Order Codes : Sub Status Codes for the ACTIV status; New Closed Not Processed Status & Sub Status Codes
	New Process Logic & Automation for Schedule and Work Order updates
